SGBL will never request your password in any way, neither by phone nor by e-mail. The user is solely responsible for the preservation and confidentiality of his passwords.

Under the "Young" heading, young users will find customized information. No personal information is requested from the children. In addition, SGBL shall not send a direct offer to any user mentioned as being minor.
